### **BOARD OF DIRECTORS MEETING MINUTES**

**LOCATION:** Arlington Community Church

**DATE:** July 11, 2019

**Closed Session.** President Nottoli opened the session at 6:45. Directors Deppe and Sherris-Watt were present. Director Modavi joined during closed session. There were no public comments and the Board adjourned to closed session.

**Regular Meeting.** Present Nottoli opened the meeting at 7:35 and reported that the Board gave direction to legal counsel. She also announced that Item 7e was pulled from the agenda. Director Modavi joined a few minutes after the meeting began.

#### **Recruitment Firm**

*Motion to Accept Recruiting Firm.* President Nottoli moved to accept the Koff & Associates proposal to hire the three new administrative positions for \$14,000 and subject to the review of the Board's Legal Counsel; Director Deppe seconded the motion. Directors Deppe, Nottoli and Sherris-Watt voted to accept the proposal; Director Modavi voted no. The motion passed 3-1.

#### **Auditor Contract**

*Motion to Accept Auditor Contract.* Director Sherris-Watt moved to authorize the General Manager to execute the agreement with Lamorena & Chang to conduct a financial audit of the fiscal year ending June 30, 2019 for a fee to not exceed \$17,000 subject to the review of Legal Counsel. President Nottoli seconded the motion. Directors Deppe, Nottoli and Sherris-Watt voted to accept the proposal; Director Modavi voted no. The motion passed 3-1.

#### **Police Officer Descriptions**

*Motion to Accept Police Officer Descriptions.* Director Sherris-Watt moved to accept the police officer descriptions with the addition of a background check and the same physical description as for captain for the permanent chief of police and President Nottoli seconded the motion. Directors Deppe, Nottoli and Sherris-Watt voted to accept the proposal; Director Modavi voted no. The motion passed 3-1.


#### **Police Salary Schedule**
