RE:	Police Chief's Monthly Report, October 2024

#### **Patrol Operations**

In October, the Kensington Police Department demonstrated its ongoing commitment to public safety by managing a total of 1296 incidents, an increase from the 1,018 incidents reported in September. Our officers engaged in 1025 proactive actions, including 130 traffic stops, which resulted in 85 citations aimed at enhancing roadway safety.

Throughout the month, officers responded to 271 dispatched calls for service, an increase from the 220 calls in September. The department produced 15 investigative reports, a decrease from 16 the previous month, reflecting our effective resolution of cases and the overall decline in reported crime. Significantly, reportable crimes fell by approximately **11%** compared to September.

Our investigative efforts this month included handling several felony cases, such as a sexual assault, a vehicle theft, and vandalism. The department successfully made one felony one felony arrest for a stolen vehicle taken from a Kensington resident, and two misdemeanor arrests, one for hit and run and the other for public intoxication at the Kensington Community Park. Analysis of crime patterns revealed that the majority of NIBRS reportable crimes occurred evenly between mornings and afternoon/evening, with Sunday having a disproportionate amount of crime compared to the rest of the week and Monday having the least.

Average response times for officers dropped to 5.72 minutes in October from 6.6 minutes in September.




Figure 1. NIBRS Offense Data




Figure 2.	<b>NIBRS</b>	Month	over	Month



**Oct 27:** Officers responded to Visalia Avenue for a non-breathing female. A dose of Narcan was administered, reviving the female until Fire Personnel arrived. Female transported to Emergency Department.

**Oct 29:** Officers contacted an individual at Kensington Community Park who was intoxicated. The suspect was arrested and transported to Kaiser Hospital in the City of Richmond for medical care.

Oct 31: Police were dispatched to Sunset Drive for a vandalism detail. A report was taken.


Oct 31: Officers responded to Norwood Avenue for a suspicious person. A report was taken.

# Training

During October, Sergeants Lande and Rivera, along with Ofc. Fajardo, completed the Taser 10 Instructors Course. On October 16<sup>th</sup>, Sergeant Lande and Sergeant Rivera taught the Taser 10 Operators Course. The course included a didactic presentation on how Tasers work, the physiology of their effectiveness, safety procedures, a review of the KPD policy for the use of Tasers, tactical decision exercises using open-source body-worn camera videos, and finally, immersive reality-based scenario training using training munitions.


Sgt. Lande completed his Perishable Skills Program (PSP) training cycle for 2023-2024 by attending Use of Force training at the Contra Costa County Sheriff's Office.

Sgt. Lande also represented the Kensington Police Department at the International Association of Chiefs of Police (IACP) conference in Boston, MA, from 10/19 to 10/22. IACP is globally the largest and most impactful law enforcement association. The conference provides a platform for attendees to learn and share new techniques, advance their knowledge, and equip their departments for ongoing success. Sgt. Lande attended panels and training such as "Creating a Team Response to Crisis Calls in a Small Jurisdiction," "Leveraging Body-worn Camera Video to Enhance Transparency and Engage the Community," and "Enhancing Law Enforcement Mobility: New and Expanded Capabilities Using Artificial Intelligence."

Ofc. Gill joined the Contra Costa County Mobile Field Force team and attended the 3-Day Basic Mobile Field Force Academy. The Mobile Field Force responds to critical incidents such as riots, major events, protests, or other situations where crowd control is required.

### **Traffic Safety**

Officers investigated a single, non-injury, traffic collision in October.



# **Chief of Police**

Officer Gill's actions responding to a report of an unconscious woman in the area of Oakview Avenue resulted in her life being saved.

Officer Gill was dispatched to the call and responded, summoning medical personnel in advance. The victim's actual location was undetermined however Officer Gill worked with dispatch and ultimately found the victim on the ground suffering from an apparent drug overdose. Officer Gill quickly administered a chemical compound all KPD officers carry with them called Narcan. This decision had an immediate and positive effect and revived her from an unconscious state. Medical professionals arrived shortly after and provided further treatment. Officer Gill's actions undoubtedly saved her life. All KPD officers receive annual training on how to handle situations like this. Officer Gill's performance was outstanding, and we are very proud of him!

We added extra staff for Halloween to ensure the safety of everyone. The night was filed with ghosts and goblins of all ages. Officers passes out stickers, candy, and toys to the kids. There were no reported injuries or significant calls for service.

### Community

October was a busy month for KPD. Our officers, Reserve Officer, and Volunteers were on hand for several community events.

The KCC hosted the annual Kensington Fall Picnic at Kensington Community Park. Officers were on hand to ensure safety and security and take part in the festivities.



Kensington PD participated in the 26<sup>th</sup> National Drug Take Back Day. This is a well-attended annual event took in 198.45 pounds of prescription drugs. Overall, Northern California collected 11,926.37 pounds of prescription medication that would otherwise end up in a landfill or worse. The next drug take back event takes place in April 2025.



Officers received Taser 10 training from instructors Lande and Rivera. These valuable de escelation options enhance officer and citizen safety and are now deployed in the field.
