Background

FEMA requires a Hazard Mitigation Plan every five years for a governmental agency to qualify for FEMA and California OES Grant Money related to natural disasters and related to the prevention of loss of life and property due to natural disasters.

The KPPCSD 2024 Hazard Mitigation Plan was part of the overall Contra Costa County Plan. It is noted as an "Annex" to the plan.

After much in the way of time and energy the FEMA has approved the plan. The last item of business for the plan to be approved is for our agency's Board of Directors to approve the attached Resolution which will be sent to the County who gathers all the resolutions and sends them to FEMA.

Hello Everyone,

FEMA has issued us the approvable pending adoption letter, meaning that local adoptions may begin. Congratulations to you all for the hard work to reach this point!

Please download and the following materials for your records. These documents serve to prove participation and the status of your annex and grant you access to the approved version of your plan for future updates.

- 1. CalOES to FEMA Transmittal Notice
- 2. FEMA Approvable Pending Adoption Notice: Email and Letter
- 3. <u>Annex Review Tool</u>: Contains feedback and areas of improvement to be considered in the next planning cycle
- 4. Approved Annex Copies: Please save both the Word and PDF Versions.

A couple things on approvable pending adoption (APA) status:

- 1. Your annex is not officially FEMA approved until it is adopted locally and confirmation of adoption is submitted to FEMA.
- 2. Your annex **must be adopted by September 18, 2025** (the day the first annex was adopted). Adoption steps should follow standard practice for your jurisdiction/agency.
- Since we are a multi-jurisdictional plan adoption documentation must be submitted to County OES at <u>OES-Staff@so.cccounty.us</u> for submission to FEMA in order to receive official FEMA approvable.
 - We will be submitting adoption documentation to FEMA on the second Thursday of every month.
 - b. Please have your documentation in by 9 AM on submission day to be included in that batch.
 - c. The first three submission days will be:
 - i. February 13
 - ii. March 13
 - iii. April 10
 - d. This will continue until all annexes have adopted and become officially FEMA Approved.

Hello Everyone,

CalOES and FEMA have completed their joint review of our second submission and found that most annexes have met the requirements! Please note, we have only received the initial

approval and not the official documentation required to continue with the adoption process. The agencies whose annexes require additional edits have already been contacted, meaning that if you have not received an email from Yahiritza, your annex does not require additional edits.

There are still some questions around adoptions and submissions that we are actively discussing with CalOES and FEMA. This includes two significant questions around whether 1) the annexes that have met the plan requirements may begin local adoptions while edits are still ongoing and 2) the submission process for local adoption letters.

Until we receive further guidance form CalOES/FEMA and the official Approval Pending Adoption (APA) documentation, **please do not begin local adoptions.** As a reminder, any adoptions before official APA status, will have to be re-adopted.

I will share more information as I receive it.

- CalOES/FEMA Resubmission
 - As of this morning, all annexes for those who participated in the revision process have been resubmitted to CalOES and FEMA for review. Great job to everyone involved on completing the revisions on such a tight turnaround!
 - While we are optimistic that the completed revisions will meet the mitigation plan requirements, please keep in mind that CalOES/FEMA may have additional feedback that would require further revisions.
 - At this time, we do not know the turnaround time for the review. Once we have a better idea, we will share that information with you.
 - o Resubmitted Annexes can be viewed here: October 2024 Resubmission
 - The versions on the County website will not be updated until CalOES/FEMA approval is received but local agencies may update the versions on their platforms while noting that the plan is still a draft.
- Please do not adopt annexes locally until we receive the official notice from FEMA that annexes approvable pending adoption
 - CalOES/FEMA will request a new adoption for any annexes adopted prior to approval.

I wanted to provide a reminder and a couple of updates.

Reminder - Applicable Stakeholder List

- Please review the attached list and remove any agencies that are not applicable to your jurisdiction
 - Think of "applicable agency" broadly (neighboring, within your jurisdictions, or agencies you could foresee partnering within during/before/after a disaster)
 - Return by end of the day on Wednesday, September 25.
 - Additional outreach documentation may be necessary if none of the agencies in one (or more) of the categories apply to you. If you did not already conduct outreach to fulfill the requirement for each of the five categories, please invite additional comments on your annex. The list of categories can be found in the email below.
 - Otherwise, no additional feedback is required.
 - For those who submitted while I was out of office, I will review and let you know if there are any changes.

Update - CalOES and FEMA - Annex Feedback

- CalOES and FEMA returned the remaining 38 annexes for revisions late Friday afternoon.
 - Most revisions are similar to what was received for the two initial annexes.
- We are working on a process and timeline for revisions. Expect an additional email and meeting invite (time and date has not been determined yet) later this week with more information.

Update - County Base Plan

- The County Base Plan and one of the annexes have been approved by CalOES/FEMA.
 - This was done because one of the participating agencies was on the verge of losing HMP funding if they did not have an approved/adopted plan by the end of the month.
- This means three main things:
 - o All cities and special districts will now be treated as amendments
 - Cities and Special Districts cannot begin adoptions until CalOES/FEMA approve their individual annex
 - Annexes have to be CalOES/FEMA approved and locally adopted by September 18, 2025 (one year from when the first piece of the plan was adopted)
- Expect more information on this when in the coming week.
